**203. FOUR (4) VIRGIN MARY STATUES.** Four (4) Virgin Mary statues seen throughout Season One. Includes two plastic, one plaster and one broken plaster statue with prop bag of heroin. \$400 – \$600

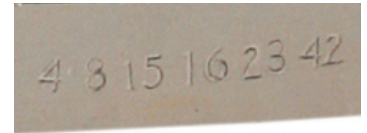

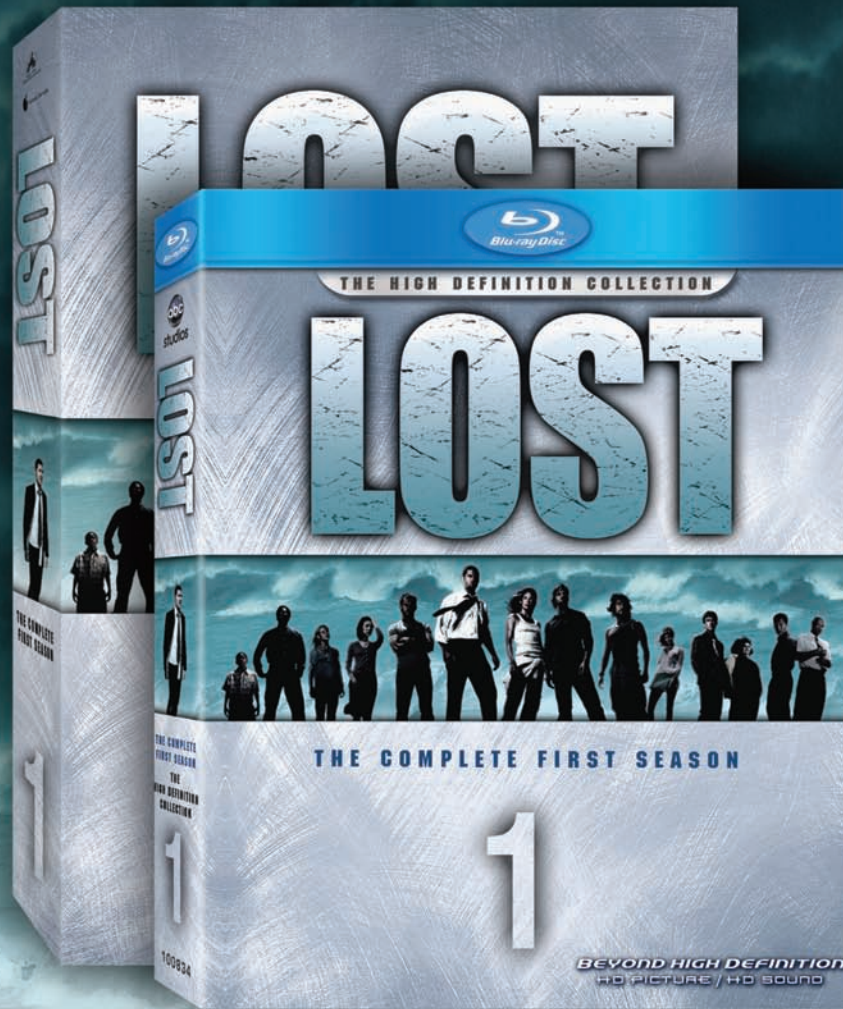
